Getting Started

Make a plan



Think about what type of fundraising you'd like to do and how you think you can achieve it.

From there you can create a checklist of what you need to do and when. Make sure to take time to plan as a good plan is the backbone of any event.

What help do you need?

We would never recommend that you run an event alone.

It's good to know there are other people to bounce ideas off and help you spread the word. They may also have skills and contacts that can help you. You

should never put yourself in a position where you are alone and no one knows where you are. Make sure if it's an event that needs packing up that someone is with you.

Set yourself a target



Keep yourself motivated by having a target for how much you want to raise.

You could be creative and design a something to help you keep track. People often use the image of a thermometer but it can be anything.

Promote your event



Social media is a great free platform for getting the message out there, creating an event page and inviting your

friends. You can keep people up to date with what's happening and ask them to share with their friends too.

Local radio and the local press will often run a piece on an event particularly if it comes with a story. If this is something you are interested in doing please email fundraising@citizensadvicecornwall.org.uk and we will see if we can help.

Posters are great on noticeboards and in shop windows, especially if it's a local event. If you need help let us know and we will send you a template.

When raising money for charity it is always great to show people what the money is for, this can help encourage more support.

If you are happy to you can also share your reasons for choosing Citizens Advice Cornwall as your beneficiary charity.

Gift Aid

If you pay tax your donation could be eligible for Gift Aid. Gift Aid allows our charity to claim an extra 25p on each £1 you donate. Contact us to find out if your donation could be eligible.

Bake Sales and coffee mornings



Everyone loves a bit of tea and cake! Whether you are dab hand in the kitchen or you buy them ready made it's a great excuse to get

together and raise some pennies.


There are some key dates in the year that you could manage your event around including; Pancake Day in February, World Biscuit Day in May and Cream Tea Week in August.

Themed parties

Most months there are a selection of food days to choose from. Why not try a few? You could try Cheese Fondue day on 11th April or Cornish Pasty Week in February.

Celebrations

Got a birthday coming up? Or how about Christmas or Easter. Whatever the occasion you can theme your fundraising activity around it.



Birthday fundraisers are easy to sign up to and popular on Facebook. Alternatively what about a birthday tea party?

Easter Egg hunts are always fun or a Christmas Fair, there are lots of options to choose from.

Games & Quizzes



Are you competitive? Get a group of friends and family together online or in-person and organise a games night.

Alternatively how about bingo or a quiz? There are lots of sites online that can help you with games and questions.

Competitions

Looking for something a bit bigger? How about organising a competitive event? A park run, battle of the bands, photography etc. Who do you know and what do they like doing? That could give you an idea.

Sales and book sales

Businesses

Corporate Social Responsibility (CSR)

Donation

Volunteering

Office Events



Host an event at your workplace. It can be for staff which can help with team building or for customers/clients as a way of promoting your business.

Simple events such as bake sales always go down well or you could go bigger and do a sweepstake or open day.

Charity of the Year

Do you or your workplace have a charity of the year? A charity of the year is where a business decides to support and raise funds for one (or more charities) during the course of a year.

Why not consider us as your chosen charity? We'd be happy to come and talk to you further about what we do and what difference your support could make.

Sponsorship

We have several options for sponsorship depending on what audience you are looking to reach. These include sponsoring an event, a member of the team or a project. Let us know if you'd like more information.

Payroll Giving

Employees can chose to make a regular donation through their salary each month which can also be topped up by the employer if they wish.

Paying your money in

Online Fundraising

If you have raised money online you don't need to do anything as it will automatically come to us, including Gift Aid, if you are eligible. There is usually a slight delay in funds getting to us, so please let us know if you have raised money for us online, so we can acknowledge your donation sooner.



If your money was donated via social media platforms such as Facebook and Instagram, we may not automatically get your

contact details, so if you would like to stay in touch please do let us know.

Fundraising Guidelines

Health and Safety

As part of planning your event or activity you should complete a risk assessment. This will help you to identify any hazards or risks that may need rectifying.

If your event is in a public place you will need to let your local council and police know. You will also need to ensure you have adequate first aid in place.

If you are using suppliers get copies of any relevant certificates and insurance.

The Health and Safety Executive provides lots of great information as well as downloadable templates for risk assessments etc.

Raffles

Whether your raffle is online or in person there are still legal requirements that you must take in to consideration.

Raffles that are drawn on the same day as the tickets are sold do not need a licence if it is for charity. If your raffle is over 24 hours from when you start selling tickets you will need a lottery licence and to print the tickets in a certain way. If you are not sure please get in contact.

Tickets for raffles including alcohol or any age appropriate items must not be sold to those underage.

Alcohol, Food and Music

If you are serving food and/or alcohol at an event you may need a licence. Speak to your local council licencing department for clarification of what you will need.

Collections and collection tins

If you are planning on organising a collection for Citizens Advice Cornwall you must let us know in advance.

Collection tins must always have a seal and there must be more than one person present when they are opened and counted.

You will need permission from the owner before placing a collection tin at an outlet.

You also need permission for collections on private property such as shops etc. and you will need a licence if it is on council land or door-to-door.

Insurance

You may need insurance for your event including public and products liability cover.

Children

If your event includes children you will require additional measures including ensuring that anyone running activities is DBS checked.

Ensure that parents are aware that their children are their responsibility and ensure you have a lost child plan in place.

Do not take pictures of children without written consent from their parents.

Do not allow children to take part in activities that are not age appropriate.
